RACING PAYMENT SERVICE

Paying invoices is time consuming, so let Weatherbys Racing Bank take the burden away with our unique Racing Payment Service. You can be confident that your bills will be paid under the control of our expert and knowledgeable team, bringing peace of mind to both owners and trainers.

To sign up, you simply set up a trainer payment mandate and we will ensure your training bills are paid within an agreed time a Racing Gold Account, a Weatherbys frame (e.g. seven days after receipt). An upper limit you are happy for us to pay can VAT Return Service. also be specified.

If you have any other racing-related invoices, you can contact us by telephone or email and we will make the payment(s) for you.

This service includes an optional cheque book for other horse-related expenses, the option to open a currency account, and to receive paper statements. You can also add an agent to the account if required. For partnerships, we can offer month-end balance splits to your individual accounts.

VAT RETURN SERVICE

Ownership of racehorses can become significantly less expensive for owners who become registered for VAT under the Racehorse Owners VAT Scheme.

The handling of VAT yourself can prove a complex, time-consuming task and our VAT Services team takes the administration away from you.

We can provide expert advice and deal with HMRC on your behalf on all VAT affairs, taking care of everything from online VAT applications to the collation and submission of quarterly VAT returns.

Registered owners have the opportunity to claim back their racing-related VAT expenses, which include:

- The original purchase price of the horse
- Training fees, veterinary and farrier bills
- Travel and accommodation costs incurred when you are watching your horse race or in training

We aim to maximise the benefits of the VAT Scheme for our clients and ensure that all paperwork is completed accurately and on time.

As part of our current account benefits, you will qualify for the following discounts:

- Racing Gold Account holders: 20% off VAT Return Service fees
- Racing Account holders and Multi Owner Account holders: 10% off VAT Return Service fees

If you have a Weatherbys Racing Bank account, and use our VAT Return Service, you will receive full use of the Racing Payment Service, for no additional cost. This means that, should you wish, Weatherbys can automatically pay your training bills on receipt and reclaim the VAT on your behalf.
